THIS ERROR WAS DUE TO A PROGRAMMING ERROR MADE BY ATLANTIC ELECTIONS SERVICE'S. MR. HULL WAS NOTIFIED OF THIS ERROR AT 6:04 AM BY ANGELA R. STEWART, THE GENERAL REGISTRAR. THE GENERAL REGISTRAR ALSO CONTACTED THE DEPARTMENT OF ELECTIONS AT 6:06 AM AND FOLLOWED GUIDANCE SET FORTH BY THEM. ALL TOTALS WERE CORRECT AND ALL THE CANDIDATES RECEIVED THE PROPER VOTES.
