Chairman Vaughn asks if there are any delegations from the public; there is no one wishing to speak.

Public Hearing: Proposed Budget 2018-2019: Public Hearing on the Budget proposed for the Fiscal Year beginning July 01, 2018

Administrator Roark reads aloud the details of the proposed Budget, totaling \$37,350,148.00.

Chairman Simmons asks if there is anyone present wishing to comment on the Proposed Budget for Fiscal Year beginning July 01, 2018;

Sonny Abbott: Mr. Abbott expresses approval of the progressive nature he witnessed while attending Board of Supervisors budget committee meetings and expresses disapproval for the lack of interest by the School Board during their budget meetings.

The Budget is scheduled for adoption on Thursday, April 26, 2018 at 5:00 p.m. in the Health Department conference room.

Presentation: Mrs. Jenny Davis-Bunn is a licensed professional counselor who wants to work with the children that are provided therapeutic care under the Child Services Act (CSA). Mrs. Davis-Bunn is seeking the utilization of CSA funding to provide in-home counseling, mentoring, and out-patient therapy to the children.

Public Hearing: Virginia Department of Transportation – Secondary Six-Year Improvement Plan: Joint public hearing to receive public comment on the proposed Secondary Six-Year Improvement Plan for Fiscal Years 2018/2019 through 2023/2024 in Nottoway County and on the Secondary System Construction Budget for Fiscal Year 2018/2019

VDOT Representative and Assistant Residency Administrator Dianna Bryant is present to conduct the public hearing and review the projects on the proposed plan; totaling \$601,673.00. Mrs. Bryant details leftover funding that will be allocated to the Rt. 40 Darvills Road Roundabout; \$260,000 in tele fees as well as tele fees from unused completed project funding. The remainder of the unused completed project funding (61,633.00) will be reallocated to projects that were not fully funded in the plan; High Point Road and Piper Lane.

Mrs. Bryant reads aloud the priority listing of the current projects on the Six-Year Plan (unpaved routes): The Grove Road – finished in 2017, Lazaretto Creek Road – finished in 2017, Good Hope Road (631) – should begin in the next 45 days, Friend Rd , Dusty Road , Loveland Road, Ingleside Road, Piper Lane (685), High Point Road (670), Rt. 40, Darvills Road Roundabout.

Chairman Vaughn asks if there is anyone present wishing to speak, either for or against, the proposed Secondary Six-Year Improvement Plan; there is no one present wishing to speak.

Vice Chairman Bowen moves to approve the Virginia Department of Transportation Secondary Six- Year Improvement Plan for Fiscal Years 2018/2019 through 2023/2024 and the Secondary System Construction Budget for Fiscal Year 2018/2019 as presented and also adopt a resolution in approval of the plan. Public Hearing: Request to amend, revoke or sustain the Special Exception Permit granted to Reuel “Todd” Tribble to establish and operate an abattoir to process meat from wild game that has been field dressed at 944 Cedar Hill Road (Rt. 610), Blackstone, VA. Chairman Vaughn asks if there is anyone present wishing to comment on the Tribble matter;

Ken Cochran, 800 Cedar Hill Road, a neighbor of Mr. Tribble, asks the Board to revoke Mr. Tribble’s special exception permit. Mr. Cochran feels that Mr. Tribble isn’t operating with the correct equipment and that there have been sights and smells produced that no neighbor should have to witness.

Administrator Roark explains that the Planning Commission held a public hearing and they recommend revocation of Mr. Tribble’s special exception permit. Administrator Roark further informs that he was contacted by Mr. Tribble and during that conversation he stated that he would be ceasing all operations of the abattoir.

Vice Chairman Bowen moves to follow the recommendation of the Planning Commission and revoke the Special Exception Permit issued to Reuel Todd Tribble to establish and operate an abattoir on his property at 944 Cedar Hill Road, Blackstone and further require him to remove any advertising signage and clean up any mishandled waste on the property. Highway Department: Mrs. Dianna Bryant, Assistant Residency Administrator, is present to receive any communications from the Board, and also provide updates on the routine maintenance and/or projects performed since the last meeting. Mrs. Bryant reports that Rt. 633, Mallory Creek bridge will be closed for repairs, Rt. 601, Robertson Road is closed and the project is on schedule, Rt. 624, Cary Shop Road, is closed and the project is on schedule, tree trimming is being completed in the County

A – Presentation of three (3) options for the Brunswick Road, Rt. 46, bridge repairs

- 1 – 3.5 mile detour, Rt. 645 to Rt. 615; trucks cannot cross Jonesboro Bridge
- 2 – 21.7 mile detour, Rt. 40 to Rt. 137
- 3 – 10.4 mile detour, Rt. 40 to Rt. 627 to Rt. 615

Mrs. Bryant explains that option 2 is VDOT’s recommendation as it would send the majority of affected traffic across roadways of similar characteristics as Rt. 46 including similar pavement structures, locals could use the shorter detour offered in option 1, and option 2 is the least costly MOT option making in the most common sense solution

8 – Vehicle License Ordinance: Treasurer Myatt and Commissioner Hudson still have questions or concerns relating to the County's Vehicle License Ordinance. Administrator Roark explains that the County's Ordinance was very closely worded like that of Appomattox County.

Commissioner Hudson questions if the County assesses a license fee to all unregistered vehicles in the County, would this be a violation of §46.2-752 of the Code of Virginia.

Attorney Williams agrees that the County may be in violation of §46.2-752 if they charge the license fee to vehicles that are not registered; he advises to only assess the license fees to registered vehicles.

Treasurer Myatt has several matters that need clarification:

1 – The County Ordinance requires emergency services agencies to submit a list of participating members to the Treasurer's Office for exemption qualification determination; why wouldn't the assessing office (COR) handle this

Attorney Williams contacted Appomattox County to find out how they handle the vehicle license process; The Commissioner is who actually determines exemption. Attorney Williams suggests the Board allow him to amend Nottoway's ordinance to reflect this.

2 – Commissioner Hudson raised the question of who would be abating the tax tickets for emergency services members should this be necessary; Attorney Williams stated the Treasurer is given exemption under the ordinance but does not address abatement. Treasurer Myatt is questioning why it wouldn't be the Commissioner who should be responsible for the abatements.

Attorney Williams reiterates that the County ordinance gives abatement authority to the Treasurer

3 – If the County assesses the license fee for utility trailers with permanent Department of Motor Vehicle tags will this be a violation of §46.2-752 of the Code of Virginia

Attorney Williams explains that assessing the license fee for utility trailers with permanent DMV tags is not a violation of §46.2-752 unless that trailer is also charged a vehicle license fee in a town within the County.

April 19, 2018

4 – The County’s Ordinance states that a fee of \$20.00 shall be paid to the County to reimburse the costs associated with a DMV Stop; the fee being charged to the County for each Stop is \$25 – doesn’t the County want to be reimbursed the full \$25.00

Attorney Williams suggests amending the County’s ordinance to \$25.00 to cover the fee.

**RESOLUTION TO ADOPT COMMONWEALTH REGIONAL COUNCIL  
REGIONAL HAZARD MITIGATION PLAN**

WHEREAS, Nottoway County is vulnerable to an array of hazards that can cause loss of life and damage to public and private property; and

WHEREAS, the County desires to seek ways to mitigate situations that may aggravate such circumstances, and the development and implementation of a hazard mitigation plan can result in actions that reduce the long-term risk to life and property from hazards; and

WHEREAS, the County is covered under a regional hazard mitigation plan that outlines ways to protect its citizens and property from the effects of hazards, in accordance with Section 322 of the Robert T. Stafford Disaster Relief and Emergency Assistance Act; and

WHEREAS, that plan must be reviewed and updated every five years for the County to remain in compliance with Section 322 of the Robert T. Stafford Disaster Relief and Emergency Assistance Act, and to remain eligible for certain types of federal assistance in the event of a disaster affecting the County; and

WHEREAS, the Commonwealth Regional Council (CRC) has undertaken an update of the regional hazard mitigation plan, which includes Nottoway County, with input from the appropriate local and state officials; and

WHEREAS, citizens have been afforded an opportunity to comment and provide input in the Plan and the actions in the Plan; and

WHEREAS, the Virginia Department of Emergency Management and the Federal Emergency Management Agency have reviewed the updated hazard mitigation plan for legislative compliance and have approved the plan pending the completion of local adoption procedures.

NOW, THEREFORE BE IT RESOLVED that the Board of Supervisors for Nottoway County hereby adopts the updated CRC Regional Hazard Mitigation Plan, as applicable to the County, and agrees to take such official actions as reasonably necessary, and as available resources allow, to carry out the proposed actions in the plan.
