LEGAL NOTICE

Public Hearing

The public is hereby notified that the Nottoway County Planning Commission and the Nottoway County Board of Supervisors will meet to consider repealing the following Zoning Ordinance sections outlined below:

Repeal Article IV, Division 19 – Renewable Energy, Sections 4.19.1 through 4.19.6 of the Nottoway County Zoning Ordinance, which includes both solar and wind energy ordinances.

Repeal the specified sections of the Zoning Ordinance that refer to ‘Renewable Energy’, including: Article II, Base District Regulations Generally, Sections 2.1.4(37); Section 2.2.4(27); Section 2.6.4(18); Section 2.7.4(17), and repeal the definition of “Renewable Energy” in Article VI, Section 6.1.2 - Definitions.

The Nottoway County Planning Commission will hold a public hearing on Tuesday, May 17th, 2022 at 7:00 pm in the basement Conference Room of the Nottoway County Health Department, located at 207 West Courthouse Road, Nottoway, Virginia 23955 to consider this amendment.

The Nottoway County Board of Supervisors will then hold a public hearing on this matter on Thursday, May 26th at 7:00 pm in the General District Courthouse located at 328 West Courthouse Road, Nottoway, Virginia, 23955 at Nottoway to consider this request.

All persons desiring to be heard on this matter are urged to be present on the date and hour aforementioned. A true and complete copy of this proposed repeal amendment application is available for review at the County Administration Office, 344 W. Courthouse Road, Nottoway, VA 23955. All persons desiring to be heard on this matter are urged to be present on the date and hour aforementioned.
